Standing up to 'Right-to-Work' across America

While anti-worker lawmakers profess to care about the middle class, their support of the so-called "right-to-work"

laws says something quite different.

Wisconsin recently adopted right-to-work when Governor Scott Walker, who has a history of siding with big businesses over workers and is flirting with a possible run for the White House, signed the legislation into law. While Governor Walker has touted his state's right-to-work law as a benefit for working families, it actually weakens the ability of unions to fight for workplace justice, including higher wages, better benefits, equal pay for equal work, and protection from exploitation.

Local 655 represents workers at our major food chains and a host of other firms who have a union voice on the job. Our members literally have Job Insurance: the protection of a union contract to ensure employers understand that they can't treat our members as their property and subject them to being fired on someone's whim. That's not available to workers in RTW states.

While the situation for workers in right-to-work states is challenging, Local 655 is encouraged by the fact that right-to-work legislation has been blocked to this point here

in Missouri, West Virginia and New Mexico thanks to the thousands of UFCW members who spoke out against the legislation.

Thanks to all our members who responded to our requests to contact your legislator. Even though the House passed the RTW bill, your support and legislator contacts were effective enough that 21 Republicans joined with Democrats to ensure that a veto by Gov. Nixon cannot be overridden. That's a clear victory!

We are also encouraged by the fact that many states and localities are acting on their own to improve standards for workers by raising the minimum wage and protecting workers from erratic scheduling practices that make it hard to balance work and caring for a family.

Unions give workers the bargaining power they need for a voice on the job and the dignity and respect they deserve, and smaller numbers of unionized workers mean less bargaining power, resulting in a weakened middle class and lower wages for everyone.

Local 655 stands with workers everywhere who are speaking out against politicians like Governor Walker and fighting for what unions fight for every day—the right to stick together for a better life.

Rest assured that Local 655 is, and will continue to be, in the forefront of the fight to keep our members free of "right-to-work (for less)"
