IMPORTANT INFORMATION FOR NEW HIRES

The collective bargaining agreement with your employer provides that you must become a member in good standing in UFCW Local 655. This means only the timely tender by you of the uniform initiation fees and periodic dues as may be lawfully required. While you do not have to become a full member of Local 655, membership in the Local provides you with very important rights in addition to the wages, benefits and job security provided by the collective bargaining agreement. These rights include the right to:

VOTE to accept or reject a proposed Collective Bargaining Agreement;

FULLY PARTICIPATE in the development of contract proposals;

VOTE in the election of your union officers;
BENEFIT from other programs such as credit cards, discount coupons, and other services available only to union members.

These rights and others are clearly set forth in the Union Constitution. Please take time to read it carefully.

If you choose to forego the above rights and not be a full member of Local 655, you may file a written objection to funding union expenditures that are not germane to the union's role as a collective bargaining representative. Individuals desiring to file an objection should notify the Local 655 Fee Administrator in writing and request a description of the further procedures which must be followed and to obtain further information as to how these fees are calculated. You may contact the Local Fee Administrator at the Union office located at 300 Weidman Road, Ballwin, Missouri 63011. Please include your name, home address, telephone number and social security number when communicating with the Fee Administrator.

This Check-Off Authorization and Agreement is separate and apart from the Membership Application and is attached to the Membership Application only for convenience. CHECK-OFF AUTHORIZATION

To: Any Employer under contract with United Food and Commercial Workers Union, Local 655, AFL-CIO

You are hereby authorized and directed to deduct from my wages, commencing with the next payroll period, an amount equivalent to dues and initiation fees as shall be certified by the Secretary-Treasurer of the Local 655 of the United Food and Commercial Workers Union, ALF-CIO, and remit same to said Secretary-Treasurer.

This authorization and assignment is voluntarily made in consideration for the cost of representation and collective bargaining and is not contingent upon my present or future membership in the Union. This authorization and assignment shall be irrevocable for a period of one (1) year from the date of execution or until the termination date of the agreement between the Employer and Local 655, whichever occurs sooner, and from year to year thereafter, unless not less than thirty (30) days and not more than forty-five (45) days prior to the end of any subsequent yearly period or termination date of the agreement between the Employer and Local 655, I give the Employer and Union written notice of revocation bearing my signature thereto.

The Secretary-Treasurer of Local 655 is authorized to deposit this authorization with any Employer under contract with Local 655 and is further authorized to transfer this authorization to any other Employer under contract with Local 655 in the event that I should change employment.
